

## <u>無衝突礦產宣告書</u> Declaration of Minerals Conflict-Free

漢保集團特此聲明所有提供給客户之產品皆為無衝突礦產之產品: Hamburg Group herein declare the Minerals Conflict-Free on products supplied to customers.

漢保集團亦正或將致力於詳實調查供應鏈確保金(Au)、鉭(Ta)、鎢(W)、鈷 (Co)、錫(Sn)這類金屬並非透過無政府軍團或非法集團,由剛果民主共和國衝突區域之礦區 開採或是循非法走私途徑取得。

Hamburg Group is taking and will take due diligence within our supply chain to assure "DRC Conflict-Free" for the metals of gold (Au), tantalum (Ta), tungsten (W), cobalt(Co)and tin (Sn) are not derived from or sourced from mines in conflict areas of the Democratic Republic of Congo (DRC), or illegally taxed on trade routes.

此外,下列國家出口之金屬皆不符合「無衝突規範」: 剛果民主共和國(DRC)、盧安達 (Rwanda)、烏干達(Uganda)、蒲隆地(Burundi)、坦尚尼亞(Tanzania)、肯亞(Kenya) (聯合國 安全理 事會認定上述國家皆為剛果礦脈之礦產)。

Either of which are controlled by non-governmental military groups, or unlawful military factions. Trade routes not confirmed to be "Conflict Free" include direct exports from the DRC, as well as exports through Rwanda, Uganda, Burundi, Tanzania and Kenya (countries of whom the U.N. Security Council note are global export routes for DRC-mined minerals).

本公司保證任何出售於客戶之產品所含金屬皆符合無衝突規範 (DRC Conflict-Free)。 We would like to confirm metals used in Products sold to RTF Corporation are "DRC Conflict-Free".

漢保集團特此制定 " 衝突礦物政策",而且使用以下承諾: Hamburg Group hereby formulated this Conflict Minerals Policy and makes following commitments:

- 1. 不購買從衝突地區來的衝突礦物。
  Not to purchase conflict minerals from mines in the Conflict Regions.
- 2. 要求供應商拒絕使用從衝突地區來的衝突礦物。
  Request its suppliers to refuse to use Conflict Minerals from the Conflict Regions
- 3. 要求我司的供應商,需管理其上游及下游供應商,必須要遵循無衝突礦物的要求。 Request its suppliers to notify their upstream/downstream suppliers to follow Minerals Conflict-Free requirements.
